





ENERGY ASSISTANCE PROGRAM

LIHEAP, or Low Income Home Energy Assistance Program will begin accepting applications for the 2017-18 winter season on October 1st for senior citizens & those receiving Social Security Disability or SSI benefits. General enrollment will begin on December 1st.



DVP, or Direct Vendor Payment, is designed to assist income-eligible households with energy services, in the form of a one-time benefit payment to the utility companies that is applied directly to the household's energy bills. The amount of the payment is determined by income, household size, and fuel type. Reconnection Assistance is used to prevent or reconnect disconnected households.

Furnace Assistance is designed to restore the home's heating system back to a safe and effective operation. Assistance is only available to approved households that have or are eligible to receive a LIHEAP benefit and whose heating systems are not operational or have been red-tagged by their utility company. The services are free of charge for income qualifying households. *Renters are not eligible to apply*.

COOK COUNTY BOARD OF REVIEW

2017 Wheeling Township assessments can still be appealed through the Cook County Board of Review. The Board sets a 30 day appeal window annually for each township in Cook County. Appeal dates will be posted on their website: www.cookcountyboardofreview.com

Using your PIN# (property index number), an appeal can be filed online or submitted during the 30-day appeal window with a Board of Review appeal form. The forms are available online, at all Board of Review locations, or from our office. If you qualify for the Senior Freeze you should not file an appeal.

The Board of Review still maintains a branch office in the Rolling Meadows Circuit Courthouse located at: 2121 E. Euclid Avenue Room 237, Rolling Meadows, Illinois 6009, Phone # 847-818-2067.

If successful in getting a reduction in your assessed value, it will be reflected on your 2017 second installment property tax bill payable in 2018. We are available to provide information and direction in filing an appeal. You may email us requesting comparables at: taxpayerassistance@wheelingtownship. com. Please have your Property Index Number available when you visit or call our office at 847-259-1515. You can find you PIN on your tax bill.

DISABLED VETERAN EXEMPTIONS

Senate Bill 107 (Public Act 99-0375) amends the Property Tax Code for the disabled veteran's standard homestead exemption for the taxable years 2015 and thereafter as follows:

- Veterans with 30%-49% service connected disability receive 2,500 annual exemption.
- Veterans with 50%-69% service connected disability receive 5,000 annual exemption.
- Veterans with 70% or more service connected disability are Completely exempt from property taxation on their primary residence

The exemption amount (along with any other exemptions such as the standard homeowner or senior exemptions are deducted from the Equalized Assessed Value (EAV), which is then applied to the tax rate to determine a taxpayer's bill. Forms will be available in January 2018 from the Cook County Assessor's Office and online at www.cookcountyassessor.com. If you received the disability exemption last year, you should receive a renewal form to complete and return to the county in early 2018.

SENIOR EXEMPTIONS

Seniors who filed for a Senior Exemption for 2016, should receive a renewal form annually, as long as you are still living at the same residence. All Seniors must complete the senior portion on the front of the form every year and return it, even if you do not qualify for the Senior Freeze. Please note that the renewal exemption forms and property tax bills will not get forwarded to a winter address. You will need to get the form online or through our officeand if you are not sending the original renewal form, you will need to attach a copy of a tax bill and your driver's license or state I.D. with the property address. If you do not receive your property tax bill, which the Cook County Treasurer mails in February, and is due March 1, you may pay online at the treasurer's site: www.cookcountytreasurer.com.

FROM THE HIGHWAY DEPARTMENT

FLOOD EVENTS... What Services the Township Can and Cannot Provide

After the most recent severe flood event that occurred in Forest River Subdivision during July, 2017, we think we should make it clear to our unincorporated residents what services Wheeling Township Road Management can and cannot provide during such events.

Wheeling Township Road Management is responsible for maintaining the unincorporated roads and road drainage systems. When a flood occurs and any road or section of road becomes flooded, the road drainage systems can no longer function until the flood water subsides below the drainage system level. When road flooding occurs, we will have ROAD CLOSED signs placed at appropriate locations to warn drivers not to proceed onto the flooded roads.

If residential flooding becomes imminent, we will do our best to warn the affected homeowners. Also, as a courtesy, we will contact Cook County Highway Department to request sandbags and sand for these residents. If the County does provide these supplies, the filling and positioning of sandbags is the responsibility of the resident. When the flooding subsides, the disposal of these sandbags is also the resident's responsibility. We do have some contacts for possible volunteer groups to help with sandbagging, which we will call on, but this is not a certainty.

If a home is going to flood, it is the responsibility of the homeowner to move any vehicles to higher ground to prevent them from being flood damaged. Vehicles can be parked at the Forest River Civic Center during flood events. We also have a contact at ComEd for disconnecting power to a residence should that become necessary.

If possible, when the flooding subsides, Wheeling Township will do its best to obtain help from Cook County to pump any lingering trapped flooded areas into the Graylynn Dr. retention area. Township cannot, however, pump out any flooded portions of private residences or property. When is the service available? Rides are available to a wide variety of locations within the Township, Monday - Friday, 9:00 am - 3:30 pm. Some locations outside the Township are covered for medical services. *Cost? \$2 each way.*

When should you call? For medical appointments, please call at least one week in advance, as buses fill up quickly (you may call up to 30 days in advance for medical appointments). For casual appointments (hair salon, grocery store, etc), you must call two days in advance. Call (847)259-7743 for more information about the program & eligibility.

VOTER REGISTRATION

If you want to vote in the Primary Election on March 20, 2018, now is time to make sure you are registered. If you are not registered, have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in future elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00 am - 4:30 pm. You will need two forms of identification (one showing your current address), proof that you are a citizen of the United States, will be 18 years of age or older by the March 20, 2018 primary election, and have lived in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization. If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website elections.il.gov. If you don't have Illinois driver's license or state ID, go to cookcountyclerk.com and complete the form online, print, sign and mail it to the address on the application. If you register by mail or online, you must bring a valid state issued picture identification when you vote for the first time. Remember - Once you have registered, you do not need to re-register unless you move or change your name.




However, remember, you must be a citizen and if you are not, you need to opt out from the automatic registration. Although the law is immediately in effect, the automatic voter registration process will be rolled out over the next year, in time for the November 2018 General Election.

VEHICLE STICKERS:

You may have also heard about the new Illinois automatic voter registration act. Eligible voters will automatically be registered through an electronic process when they apply for a driver's license or state ID at the Secretary of State's facility.

For residents of **unincorporated** Wheeling Township – *don't* get caught without a valid vehicle sticker! The deadline for displaying the new sticker was July 5, 2017. If you missed the deadline, it is still cheaper to buy a vehicle sticker and pay the late fee than to receive a ticket. The Cook County Vehicle Stickers for the **unincorporated** areas are available for purchase at Wheeling Township. Online purchases are



Stickers are valid from July 1, 2017 until June 30, 2018. The cost for stickers varies, but generally an automobile is \$80, a small truck is \$100 and a motorcycle is \$25. Senior citizens (65 years and older) can receive up to two stickers free of charge. Others eligible for no fee stickers are individuals with physical disabilities and disabled veterans. If you have purchased a vehicle within the last 30 days or moved to an unincorporated area within the last 60 days - you will not be charged a late fee. When you come to purchase vehicle stickers, Wheeling Township cannot accept cash or credit cards, so please bring a check or money order.
