After serving 37 years at Wheeling Township, we bid farewell to long-time **Director of Finance and Administration, Josephine (Jo) Stellato**, who retired on June 1st. Over the years, Jo has been very instrumental in the growth of the Township, serving under 5 different Administrations with the utmost attention to detail, direction and dedication.

Through her direction, we saw the growth and impact of the organization — from the **Wheeling Township Transportation Services**, which annually provided over 25,000 rides to assist seniors and disabled adults — to the **"Client Choice" Food Pantry.** This model allows participants the opportunity to shop from the shelves for the items and perishables that their families normally consume. Her dedication has provided nutrition and dignity to over 5,000 families and seniors within the Township this past year alone!

She also was devoted to working with the Senior Services and Disabilities Department to help with the growth and expansion of the **Meals on Wheels Program** which, in combination with Lutheran Home Culinary Services department, and the countless and dedicated Volunteer Drivers, provided over 13,000 nutritional and dietary restricted meals to our homebound residents in the past year.

Jo Stellato and past Supervisor Michael Schroeder, DDS, were very instrumental in the

formation of the Wheeling Township Mobile Dental Clinic. Through Stellato's grant writing and determination, in collaboration with Northwest Community Hospital and Elk Grove, Palatine, and Schaumburg Townships, they were able to provide low-cost or in some cases pro-bono dental services for low-income families and children, especially during the school year when dental care is mandated by the state.

Jo has also been responsible for many spin-off programs that have proved successful just by her involvement and dedication. In November of 2014, she initiated a program that involved transportation for Great Lakes Naval Training recruits, reaching out to the community to help raise the funds to provide a motor coach to afford 50 new recruits the opportunity to be hosted to a Thanksgiving at American Legion in Arlington Heights. Through an outpouring of generosity to her request, the very successful "Seats for Sailors" program was born!

Jo has always been a strong advocate of utilizing all available resources responsibly. Smart government has been the cornerstone of her philosophy in all her years of dedicated leadership. She was instrumental in the development of **Wheeling Township's Strategic Plan** – including the reduction of reserves, establishing partnerships within governmental bodies, and applying for and procuring many grants lowering the tax burden on services to Township residents.

It is with mixed emotions that we bid Jo farewell. She had been a professional in every sense of the word, as well as an advocate, leader and friend to all of us involved within Wheeling Township. She has tirelessly shared her time, talents and treasures with the Township on behalf of the entire community. ## **2017 2nd INSTALLMENT PROPERTY TAX BILLS**

You should have received your 2017 2nd installment tax bill. The due date is August 1, 2018. If you did not receive your tax bill, you can print a duplicate bill online at: **www.cookcountytreasurer.com**, or call the Cook County Treasurer's office at (312) 443-5100.

Property tax bills can be paid by mail, online, or in person at any Chase Bank location, or at the Cook County Treasurer's office in Chicago at the County Building at 118 N. Clark Street. To pay at a Chase Bank location, you will need an original or duplicate tax bill, which can be found on the website. You can pay online at the Treasurer's website www.cookcountytreasurer.com with the property index number and bank account routing number. There is no fee for paying in this manner.

Please review your bill carefully, and contact us with any questions at (847) 259-1515. If you are missing an exemption you are entitled to, you may file a certificate of error to obtain a refund. You may also contact Cook County Assessor's Office in Skokie at (847) 470-7237 or the Chicago Office at (312) 443-7550 regarding missing exemptions.

Please note that any and all Homestead exemptions are permitted on one property only and it must be the owner's principal residence. Any exemptions taken on properties other than the owner's principal residence could be deemed "erroneous" and, therefore, subject to repayment with interest and possibly penalties.



#### **2018 COOK COUNTY ASSESSOR APPEALS**

Wheeling Township is tentatively scheduled to open July 26th, for a 30 day period. Check the website **www.cookcountyassessor.com** for updates. We can assist you with providing comparables and direction on filing an appeal. Contact us by email at **taxpayerassistance@ wheelingtownship.com**. Please provide your property index number and we will email you with possible comparables and instructions for an online appeal at **www.cookcountyassessor.com**. You may also call us at (847) 259-1515 or visit our office for assistance.

If you receive a reduction, it will be reflected on the 2nd installment bill payable in 2019. You cannot "appeal" your current tax bill.

## TOWNSHIP ROAD MANAGEMENT Help Keep Drainage Ditches Clean and Flowing...

With all the recent heavy rainfalls, we thought it would good to remind our unincorporated residents that our roads use ditch and culvert systems to handle drainage. They are designed to collect moisture from the road pavement and elevated properties, and drain it into storm sewer basins at strategic locations. To function as intended, these ditch and culvert systems depend on mutual Township and resident cooperation. The Township is responsible for maintaining drainage pipes that cross under roads and the storm sewer system that the basins drain into.

Township residents are responsible for their driveway apron and the culvert that runs beneath it. This means keeping the pipe clear of obstruction to allow water to flow freely through it. Water pressure from a garden hose should be sufficient to clear a culvert of debris if done on a regular basis. If debris is allowed to become packed, a contractor with more powerful equipment may be required. In addition, residents are responsible for maintaining the ditch in the front of their property by simply raking out leaves and grass clippings



that may accumulate. It is important to grow and maintain a grass covering in the ditches to prevent silt from accumulating and clogging culverts and drainage pipes downstream.

This mutual resident and Township cooperation will help assure that the entire drainage system operates at its maximum capacity for the benefit of both you and your neighbors, and help keep costly drain system and road repairs to a minimum.

On November 6, 2018 the General Election will be held for Governor,<br/>Statewide Offices, State Senator, State Representative, and U.S. Con-<br/>gressional Representatives. If you want to vote in these elections, now<br/>is time to make sure you are registered. If you are not registered, have<br/>just moved into the Township, have moved to another residence in the<br/>Township, or changed your name, you need to register to be able to<br/>vote in this and future elections. To register, come to the Clerk's Office,<br/>Monday-Friday, between 9:00-4:30. All you need are two forms of iden-<br/>tification (one showing your current address), be a citizen of the United<br/>States, be 18 years of age or older by the November 6, 2018 General<br/>Election, and live in the Township for at least 30 days before the election.<br/>For naturalized citizens, you must prove the date of your naturalization.Court<br/>Court<br/>Court<br/>your

If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website elections.il.gov. If you don't have a driver's license or state ID, go to cookcountyclerk.com and complete the form online, print, sign and mail it to the address on the application. If you register by mail, you must bring a valid state issued picture identification when you vote for the first time.

Additional information about the election and early voting can be found at https://www.cookcountyclerk.com/elections/. Voters do not need to provide an excuse or reason why they cannot vote on Election Day. Government-issued photo ID is not required, but is helpful if there is a question about the voter's registration, address or signature. Providing an ID can also speed up the process because there are ID card readers at every polling place check-in station.

Mail Ballots: Any registered suburban Cook County voter may request a mail-in ballot at https://mailvoting.cookcountyclerk.com. Once Cook

County verifies your registration and processes your application, Cook County will send a paper ballot to the mailing address you designate on your application. The deadline to apply is five days before an election. If you do not have one of the online application requirements, or if you prefer to apply on paper, you may download, print and sign a mail ballot application and send it to the Cook County Clerk's office. You can also get a mail ballot application at our Clerk's office.

**Election Judge Jobs:** Those interested in earning some money while serving on Election Day can serve as an election judge. Earn \$190 as an Election Judge or \$340 as an Equipment Judge. You must be a U.S. citizen registered to vote in Cook County or a High School student with at least a 3.0 GPA. The duties include completing online and hands-on training classes, helping set up the polling place with your fellow judges, and working Election Day from 5 a.m. until the results are transmitted and the equipment has been packed up at the end of the night. You can apply and learn more at Cook County Board of Elections **https://www.cookcountyclerk.com/agency/work-election-day**. You may also apply at Republicans of Wheeling Township by calling (847) 632-1774 or Wheeling Township Democrats online at **https://wheelingdems.com**.

### **VEHICLE STICKERS:**

For residents of **unincorporated** Wheeling Township – *don't get caught without a valid vehicle sticker!* The new stickers should



have been purchased and displayed by July 2, 2018 to avoid a ticket and an increased cost of buying the vehicle sticker. If you missed the deadline, it is still **cheaper to buy a vehicle sticker and pay the late fee than to receive a ticket** and still have to pay the late fee. The Cook County Vehicle Stickers for the **unincorporated** areas are available for purchase at Wheeling Township. Online vehicle sticker purchases are also available at the following link - https://www.cookcountyil.gov/ agency/department-revenue.

Stickers are valid from July 1, 2018 until June 30, 2019. The cost for stickers varies, but generally an automobile is \$80, a small truck is \$100 and a motorcycle is \$50. Senior citizens (65 years and older) can receive up to two stickers free of charge and others eligible for no fee stickers are individuals with physical disabilities and disabled veterans. If you have purchased a vehicle within the last 30 days or moved to an unincorporated area within the last 60 days - you will not be charged a late fee. ening circumstance, such as eviction or utility disconnection. Residents must complete an application, provide verifications and qualify based on financial and non-financial factors.

The General Assistance staff can assess your situation and determine for which of our many programs you may qualify, such as Food Pantry or Mobile Dental Clinic. We can also screen you for DHS programs such as SNAP or Medicaid. We are **Neighbors Helping Neighbors**, so don't be shy! Call us or stop by to see how we can help you.

## **EASIER SNAP APPLICATIONS HERE...**

Wheeling Township is an online **SNAP** (Supplemental Nutrition Assistance Program) application site. Online renewals of existing **SNAP** benefits are also available. Submitting an application online offers an immediate, printed receipt and can help expedite the process. Call the Township at 847-259-7730 to schedule an appointment.

- 1. Driver's License or State of Illinois ID card
- 2. Social Security card
- 3. Paystubs for the last 30 days
- Other income verification such as Social Security, SSI, Pensions, Unemployment, etc.
- 5. Rent receipt or mortgage statement
- 6. Proof of medical expenses for the last 30 days
- 7. Medicaid card or notice from IDHS with case ID number, if applicable

When should you call? For medical appointments, call at least one week to 10 days in advance, as buses fill up quickly (you may call up to 30 days in advance for medical appointments).
