

From the Supervisor... Michael B. Schroeder

Wheeling Township cares for the community with a myriad of social services, while always keeping the resulting liability to homeowners in the forefront of our planning. Our elected officials and professional staff take pride in each and every program the township offers. We have one of the lowest local tax rates, balanced budgets, and provide full transparency. Many of our programs function with little or no cost to taxpayers because of a legion of dedicated volunteers and donors. See page 3 for a list of some of our generous and caring partners.



As you can see on the chart to the left, less than 1% of the average Wheeling Township homeowner's property taxes - or \$60 per year - finance all the services provided. We are proud to be the safety net for those in need, as well as for the not-for-profit agencies we fund. This is especially critical at a time when many agencies are struggling to stay afloat because of the state's dire financial crisis and budget impasse.

A recent Tribune article highlighted one of the flawed recommendations from the Local Government Consolidation Task Force that allows the ability to consolidate local townships into counties or villages. Perhaps that could work in smaller townships that don't provide many programs... Wheeling Township is the second largest township in Cook County with 154,000 residents. Arlington Heights Mayor Tom Hayes was quoted in the article as saying "the village relies very heavily on Wheeling Township, especially for social services for our residents that the village cannot afford to provide. The village would obviously have to increase staffing and there would certainly be a lot of costs that would end up being passed on to the taxpayers and residents".

There is support for the efforts to reduce the number of governmental units, but the needs of our residents, the quality of service, and the cost of service must be considered. Consolidating Wheeling Township's many services into villages or Cook County would come at a higher cost to taxpayers, likely make accessibility difficult, and could lead to fewer essential programs. As a result of conservative financial planning and sound fiscal management, Wheeling Township will be able to offer valuable services for many years to come — with the biggest bang for your buck!







SENIOR RENEWAL APPLICATIONS WERE MAILED

Under current law, Senior Exemptions must be renewed every year. Anyone who received a senior exemption on their property in the past and still qualifies for the exemption must submit a renewal form each year. The Cook County Assessor's Office mailed senior citizen renewal applications for senior citizen property tax exemptions in early January. Those renewal forms are to be returned to the Cook County Assessor's office by **February 3, 2016**, or as soon thereafter as possible. It is not too late to return the forms if you have not yet done so.

The renewal form that was mailed is a two-part application. THE FIRST PAGE OF THE RENEWAL APPLICATION MUST BE COMPLETED, SIGNED AND RETURNED TO THE COOK COUNTY ASSESSOR BY ALL SENIORS entitled to the senior exemption on their principal residence. The Senior Freeze worksheet need only be completed and signed by those seniors who qualify for the Senior Freeze exemption. Total household income for the Senior Freeze exemption cannot exceed \$55,000 for the 2014 income tax year and the senior must have resided in the home as a principal residence for January 1, 2014, and January 1, 2015. The senior applications that have been mailed are for 2015 property taxes payable in 2016. The savings from the exemptions will appear on the second installment tax bills scheduled to be mailed in July of 2016. 2015 first installment property tax bills are estimated bills (55% of the previous year's total) and no exemptions are deducted from the first installment. First installment bills are mailed in February and due in March.

Eligibility for Senior Citizen Exemptions (Born in 1950 or Earlier)

There are two senior citizen property tax exemptions:

- 1) *The Senior Exemption,* available to all seniors regardless of income, reduces the Equalized Assessed Value on your 2nd Installment bill by 5,000. That can equate into a savings of \$400 or more annually on the property tax bill.
- 2) **The Senior Freeze** may provide some seniors with additional savings if the combined income of all occupants in a senior's household is less than \$55,000 (for income tax year 2014), and if the senior has been an owner-occupant of the house since January 1, 2014.

Exemptions can only be taken on one property, and that must be the owner's principal residence. One senior/senior freeze exemption per household is permitted.

If you have questions, need a form or help in completing the form, please contact us at **847-259-1515** or by visiting the Wheeling Township Assessor's office. We ask that you have the **14-digit property index number (PIN) available** when you call or visit with any property tax questions. The PIN can be found at the top of your property tax bill.

Homeowners who were born in 1950 and turned sixty-five in 2015 will not receive senior application forms when the senior renewal forms are mailed. A first-time applicant must complete the 2015 Homeowner/Senior Exemption application or the 2015 Senior Freeze application and attach a copy of the most recent property tax bill and a current driver's license or a valid Illinois State I.D at the address of the subject property. The forms are available online at www.cookcountyassessor.com or from our office. They can be mailed to the address on the form or dropped at our office for forwarding to the Cook County Assessor's office. Homeowners who were born in 1951 and will turn 65 in 2016 will not be eligible for the senior exemptions until 2017 when Cook County property owners pay on property taxes for 2016.

New Homeowner Packets & Disabled Persons & Disabled Veterans Renewal Forms

New Homeowner Packets and Disabled Persons and Disabled Veterans renewal exemption applications will be mailed sometime after the senior renewal exemption applications are mailed. The changes to the Disabled Veterans' exemptions passed by the Illinois legislature in 2015 are reflected on the 2015 forms.

Service hours are 9:00 a.m. to 3:30 p.m. Monday through Friday within the Wheeling Township boundaries, with some exceptions for medical services.

Wheeling Township Partners with IDOT to Install Traffic Signal at the Intersection of Dundee Rd. and Portwine Rd.

Portwine Rd., once a quiet two lane

forested road between Dundee Rd. and Lake Cook Rd., has over the years become a very busy traffic avenue connecting these roads. So much so that years ago, for safety concerns due to the high volume of traffic along Lake Cook Rd., a traffic signal was installed at Lake Cook Rd. and Portwine Rd.

In more recent years, the traffic along Dundee Rd. has also increased to the point that, again for safety concerns, a traffic signal was deemed appropriate for the intersection of Dundee Rd. and Portwine Rd. After a two year traffic flow and environmental study, along with completing formal agreements of financial cooperation between the Federal Government, IDOT and neighboring governmental bodies, including Wheeling Township Road District, this traffic signal installation was completed in September, 2015. We are grateful to IDOT for identifying the need for this project and for allowing us to participate in it.

VOTER REGISTRATION

The Illinois Primary Elections for President and Congress are scheduled for March 15, 2016. If you have just moved into the Township, have moved to another residence, or changed your name, you need to register to be able to vote in future elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by the next election, and live in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization. You may also register to vote at the Cook County Clerk's Office at 69 W. Washington Street, Room 500, Chicago, Illinois or at the Rolling Meadows Court House, Clerk's Office, located at the corner of Wilke and Euclid in Rolling Meadows. You can also print a voter registration application at cookcounty-clerk.com and mail it to the address on application. If you register by mail, you must bring a valid state issued picture identification when you vote for the first time. The last day to register to vote is February 16, 2016. Remember - Once you have registered, you do not need to re-register unless you move or change your name.

MOST SEVENTEEN-YEAR-OLDS CAN VOTE: Most Illinois 17-year-olds are eligible to register and vote in a primary election. U.S. citizens who were born on or before Nov. 8, 1998 can register and vote in the March 15, 2016 Primary Election because they will turn 18 by the November 8, 2016 General Election.

JUDGES OF ELECTION: Two positions are available for working Election Day, election judge and equipment manager. Election judges can receive up to \$175 and equipment managers \$300 because of greater training and responsibilities. The positions require successfully completing training, assisting with polling place set-up before Election Day and working Election Day. You must also be a registered voter and live in Cook County. If you would like to serve as an election judge or equipment manager for the March 15, 2016 Primary Election, contact either your Republican headquarters at 847-632-1774 or Democratic headquarters at email info@wheelingdems.com. You may also get information by visiting the Cook County Clerk's website.

ABSENTEE BALLOT APPLICATIONS: If you have someone in your household or a child away at school who cannot get to the polls to vote, an absentee ballot application can be sent to him or her just by calling the Clerk's Office, 847-259-7730. You can also download an application online by going to "cookcountyclerk.com". When arriving at the site, go to the left side of the page to "Mail Voting", then to "Apply to Vote by Mail", and then download an application.

EARLY VOTING: Early voting will be held at the Arlington Heights Village Hall, 33 South Arlington Heights Road, Arlington Heights. It will start February 29, 2016 and continue through March 14, 2016. The hours are: Monday – Saturday, 9:00 – 5:00; Sunday, 9:00-3:00. In an effort to prevent vote fraud and double voting, the State law requires early voters to display identification to an election official before receiving a ballot. Valid forms of identification include a driver's license, state issued ID card or another government-issued ID with a photograph. Voters who participate in early voting must vote in person. Your ballot will remain secret and securely stored, just as state law calls for, by the judges of election serving here. The names of the early voters are available to the public and are updated each day during early voting.

KEY DATES

2/16/2016 Last day to register to vote

2/17/2016 First day of grace period registration and voting

2/29/2016 First day of early voting

3/10/2016 Last day to request a mail ballot, including military and overseas voters
