


Despite the rash of teardowns in the Chicago area, some of



From the Assessor – Jerry Sadler SENIOR RENEWAL APPLICATIONS WERE MAILED

Under current law, Senior Exemptions must be renewed every year. Anyone who received a senior exemption on their property in the past and still qualifies for the exemption must submit a renewal form each year. The Cook County Assessor's Office mailed senior citizen renewal applications for senior citizen property tax exemptions in early January. Those renewal forms are to be returned to the Cook County Assessor's office by February 4, 2015, or as soon thereafter as possible. It is not too late to return the forms if you have not yet done so.

The renewal form that was mailed is a two-part application. **THE FIRST PAGE OF THE RENEWAL APPLICATION MUST BE COMPLETED, SIGNED AND RETURNED TO THE COOK COUNTY ASSESSOR BY ALL SENIORS** entitled to the senior exemption on their principal residence. The Senior Freeze worksheet need only be completed and signed by those seniors who qualify for the Senior Freeze exemption. Total household income for the Senior Freeze exemption cannot exceed \$55,000 for the **2013 income tax year and the senior must have resided in the home as a principal residence for January 1, 2013, and January 1, 2014**. The senior applications that have been mailed are for 2014 property taxes payable in 2015. The savings from the exemptions will appear on the second installment tax bills scheduled to be mailed in July of 2015.

Eligibility for Senior Citizen Exemptions (Born in 1949 or Earlier)

There are two senior citizen property tax exemptions:

- 1) *The Senior Exemption,* available to all seniors regardless of income, reduces the Equalized Assessed Value on your 2nd Installment bill by 5,000. That can equate into a savings of \$400 or more annually on the property tax bill.
- 2) **The Senior Freeze** may provide some seniors with additional savings if the combined income of all occupants in a senior's household is less than \$55,000 (for income tax year 2013), and if the senior has been an owner-occupant of the house since January 1, 2013.

Exemptions can only be taken on one property, and that must be the owner's principal residence. One senior/senior freeze exemption per household is permitted.

If you have questions, need a form or help in completing the form, please contact us at **847-259-1515** or by visiting the Wheeling Township Assessor's office. We ask that you **have your property index number available** when you call or visit with any property tax questions.

Homeowners who were born in 1949 and turned sixty-five in 2014 will not receive senior application forms when the senior renewal forms are mailed. A first-time applicant must complete the 2014 Homeowner/Senior Exemption application or the 2014 Senior Freeze application and attach a copy of the most recent property tax bill and a current driver's license or a valid Illinois State I.D at the address of the subject property. The forms are available online at www.cookcountyassessor.com or from our office. They can be mailed to the address on the form or dropped at our office for forwarding to the Cook County Assessor's office.

Homeowners who were born in 1950 and will turn 65 in 2015 will not be eligible for the senior exemptions until 2016 when Cook County property owners pay on property taxes for 2015.

New Homeowner Packets and Disabled Persons and Disabled Veterans renewal exemption forms will be mailed sometime in late January or early February 2015.

We are now gearing up for the Consolidated Election to be held on Tuesday, April 7, 2015. These elections are for local offices such as village boards, school boards, and park and library boards throughout our Township. For example, the residents of Arlington Heights will elect four Village Trustees in a nonpartisan Consolidated Election on April 7. Mount Prospect voters will vote to elect three (3) trustees to serve on the Mount Prospect Village Board from May 1, 2015 through April 30, 2019. You can check the Cook County Board of Elections website for information about the elections in your area at the following website: http://www.cookcounty-clerk.com/elections/2015elections/Pages/default.aspx .

VOTER REGISTRATION: Once you are registered, you do not have to register again, unless you move to another residence or change your name. If you need to register to vote, you must register by March 10, 2015 to vote on April 7.

You can register at the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by Election Day (you can be 17 years of age when registering as long as you are 18 years of age on election day), and live in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization (naturalization certificate is good proof). You may also register to vote at the Rolling Meadows Court House, Clerk's Office, located at the corner of Wilke and Euclid in Rolling Meadows.

Online Registration: Illinois has also enacted online voter registration at https://ova.elections.il.gov. When registering online, you will need to have a state issued driver's license or state-issued ID. Those who register online will be required to enter the date the ID was issued as well as the last four digits of their social security number. The information will be checked against existing voter registration databases and also against a database run by the Illinois Secretary of State's office that keeps signatures on state issued identification or driver's licenses. The check of signatures is to prevent voter fraud. A voter's signature must match the one on file in order to vote. If there's a discrepancy, those who register online may be required to provide additional information before they can vote or they may receive a provisional ballot.

JUDGES OF ELECTION: Election judges can receive up to \$175 every election and equipment managers \$300. This includes working Election Day, successfully completing training and assisting with polling place set-up before Election Day. If you would like to serve as an election judge for the April 7, 2015 Consolidated Election, contact either the Republican headquarters at 847-632-1774 or Democratic headquarters at http://wheelingdems.com. You may get information by visiting the Cook County Clerk's website at http://www.cookcountyclerk.com/elections /election judges. To qualify, you must be a registered voter and live in Cook County.

VEHICLE STICKERS: If you just moved into an unincorporated area, you can buy vehicle stickers ¹/₂ price if purchased within 60 days of moving. If you purchased a car, vehicle stickers are also ¹/₂ price if bought within 30 days of buying the car.

We have received requests for details about the marking of trees in some unincorporated areas. The following article from The Forest Preserve of Cook County may be of interest to all residents, especially those in the unincorporated areas near Portwine Road and Forest View Drive.

HABITAT RESTORATION TO BEGIN NEAR WHEELING

Starting in December 2014, the Forest Preserves of Cook County will begin a new phase of work this month to restore 259 acres of forest preserve land near northwest suburban Wheeling. Contractors will remove a large number of trees from the Portwine, Dam #1 Woods and Willow-Sanders properties, which stretch from Willow Road in the south to Lake-Cook Road in the north. The project began last winter with smaller-scale, targeted brush clearing in more sensitive areas. This next phase will be more dramatic.

FUNDING FOR THESE AGENCIES PROVIDED BY WHEELING TOWNSHIP

Wheeling Township funds a variety of important human care services for residents of all ages. Because of Township funding, services

Many of the trees being removed are invasive species that encroached on previously open land in the absence of fire. Others were planted in the middle of the last century, when conservation efforts were biased toward preserving forested landscapes. As the field of conservation has evolved, however, scientists have come to understand the critical role of grasslands and other open environments in preserving our region's biodiversity.

The major restoration push will continue through the winter, and aims to restore habitat for plants and animals native to our prairies and woodlands. Removing trees will increase the amount of sunlight that reaches the ground, encouraging the growth of grasses, sedges and wildflowers. These will provide food and shelter to a greater diversity of wildlife, as well as reducing soil erosion. In some areas, the work will leave selected trees in place, creating savanna and providing a buffer from street traffic.

The restoration work this winter will cost \$500,000, and is being paid for with wetland mitigation funds from the Illinois Tollway Authority. The Forest Preserves will be using most of the wood removed for restoration to produce lumber and firewood. (It is typically either burned or chipped onsite.) This will save approximately \$235,000 over the course of the project.
