**ANNUAL SINGLE TOWNSHIP ROAD DISTRICT**

TAX LEVY ORDINANCE 2012

To be filed with County Clerk, County of Cook for Wheeling Township.

To the County Clerk of said County:

I, Paula Ulreich, do hereby certify that I am the Township Clerk duly elected, qualified, and acting in and for the said Township; and that in pursuance of authority vested in them by "An Act to revise the law in relation to township organization," approved March 4, 1874, as amended, the Board of Trustees in a meeting assembled on December 11, 2012, did direct that there be raised by general taxation for the year 2013 the amounts herein set down, to be levied upon all the taxable property in said Township, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law, and the amounts so required are itemized and needed for uses and purposes as follows, as appears from the record of the proceedings of said Board of Town Trustees meeting, on file in my office, to-wit:
