ASSESSOR: the report Assessor Sadler was:

- The Cook County Treasurer's office mailed the 2015 2nd installment property tax bills July 1, 2016 with a due date of Monday, August 1, 2016. During the month of July, Assessor's Office have filed 161 property tax bill corrections (Certificate of Error) for missing exemptions.
- The Cook County Assessor's office mailed reassessment notices to taxpayers opened Wheeling Township for 2016 property assessment appeals on July 2016. The last date to file an appeal with CCAO is Thursday, August 11, 2016. The Assessor's Office has to date assisted over 528 property owners with assessment appeals. There are over two weeks left in the assessment appeal period, and a higher number is anticipated.
- Assessor's Office has scheduled a property tax seminar with the Cook County Assessor regarding the triennial reassessment appeal process. It will be held at the Arlington Heights Library on Wednesday, July 27, 2016 at 7:00 p.m.

ADMINISTRATIVE REPORT: Administrator Stellato reported:

- Supervisor Penner and Administrator Stellato attended a Metropolitan Township
 Association meeting hosted by Schaumburg Township on Wednesday July 6, 2016.
 Topics discussed were the six month State budget passage, legislation on Local
 Government consolidation, HB4379 Travel Expense Control Act, and the planning for
 a Legislative Summer Outreach dinner. An ordinance will shortly be introduced to the
 Wheeling Township Board that will regulate the reimbursement of all travel, meal, and
 lodging expenses. Ms. Stellato will keep the Board informed of plans for a summer
 outreach dinner with legislators when finalized. An update of the MTA video was given
 and the Palatine Township Supervisor suggested Townships investigate
 PublicOfficials.org for a service that provides new resident contact information.
- There will be a MTA educational program on Employee Performance Reviews on Wednesday September 7 at 8:30 a.m. hosted by Elk Grove Township. Administrator Stellato will attend.
- With the help of Julie Villarreal, Linda Hallett, and Lynndah Lahey, Ms. Stellato conducted an Active Shooter Training for staff and agencies in the Wheeling Township Community Center. 40 people attended. Training videos and books were used that were recommended by the Wheeling Police Department. For safety reasons, Wheeling Township is updating Emergency Kits and will post floor plans throughout the building.
- The Summer Newsletter has been mailed, and Ms. Stellato has already received close to \$400 in donations for the Seats for Sailors campaign. She also received a call from the Wheeling Amvets; they saw our newsletter and wanted to ask for help with Amvets Thanksgiving program. Administrator Stellato explained that the newsletter article only mentions the American Legion in Arlington Heights but because our intent is to make a holiday experience available to military, perhaps our next campaign can include the Amvets.
- Chris Guth asked Ms. Stellato to share a story with the Wheeling Township Board. An elderly husband and wife were down on their luck and living in a rundown house in Berkley Square. They hardly had any income, and the house was in dire need of repairs. Wheeling Township arranged for help with the A-Ok Program, Paint A Thon, Meals on Wheels for a while, Friendly Visitor, etc. Chris ran into him the other day both he and his wife got jobs, and they are making ends meet. He told her he would never forget the help they received from Wheeling Township.

NEW BUSINESS

INSURANCE PACKAGE RENEWAL: Administrator Stellato reported that insurance broker Bill Bradish couldn't be at the Board Meeting, and if we have questions he can answer them by email or attend our next meeting. Renewal premiums are lower than the expiring premiums. We are waiting for the confirmation of the Employee Dishonesty premium; it's been \$1,564.00 for a number of years through the Hanover Insurance Company. We are anticipating it's going to be the same, but we haven't received the fixed quote yet. We did see a rise in the Supervisor's bond; it went from \$8,600 to \$10,400. This is because public officials' downstate were charged with embezzlement which resulted in rate increases for everyone. Selective and Hanover are A+ rated companies. Ms. Stellato stated that Mr. Bradish reported that in the nation, these two companies are in the top 7 % of all companies that are rated, and Selective has been in that category for 50 consecutive years. Mr. Bradish believes these are good companies and recommends we renew our premium with Selective and Hanover, for This is everything accept for the bus insurance. The renewal for transportation coverage comes due in October and that premium will probably be about The Supervisor has a separate bond; Trustees are covered under the townships liability policies. This is because the Supervisor is responsible for all funds and the Trustees do not handle money.
