CITIZENS TO BE HEARD

John Nuncal thanked the Board for hiring Northfield Township Road Management for snow removal and praised their work. He also spoke about Forest River Fire Protection District.

OFFICIALS' REPORTS

ASSESSOR: Assessor Sadler reported:

- Over 1,000 constituents visited Assessor's Office this past month. It was
 primarily seniors filing or renewing their exemptions, followed by Disabled
 Veterans and those who qualify for the Disabled Person Exemptions. The
 deadline to file is April 1 to receive the deduction on the 2nd installment tax
 bill.
- The tax bills were mailed and are due March 1st. The bill is now available on the Cook County Treasurer website, making it much easier to us to answer taxpayers' questions, as well as provide a copy for those who need one to make a payment at Chase Bank.
- This year Wheeling and other Townships in the Northwest suburbs will be reassessed (last triennial was 2016). Cook County Assessor has set a tentative opening date for July 5th for 30 days. If assessments increase significantly, we expect high volumes of office visits and phone calls.
- Taxpayers who appealed with the Board of Review in December should receive decision letters in March.
- The property where Goebert's farm used to be was sold in 2016, but apparently no taxes have been paid for several years. It is possible there are \$300,000 to \$400,000 in back taxes owed.

 Fridays a month starting in March. The Veteran Service Officer will be
 Shynae Murphy. She will be here the 2nd and 4th Fridays of the month.
- We will have Field Representative from IMRF coming March 27th to give the employees a presentation on their IMRF Benefits.
- On February 15th, Supervisor Penner, Trustee O'Connell, Director of Senior and Disability Services Lynndah Easterwood Lahey and myself attended the Village Arlington Heights "Hearts of Gold" awards. One of our Senior Advisory Board member, Jack Muldoon won the Young at Heart award and Dianna Enrenfried who prepares our newsletter won the Business Mentor award.

2019-20 AGENCY FUNDING DISCUSSIONS:

Ken Jochum who served on the Agency funding Committee provided information on the agencies seeking funding. He noted that some residents live in Wheeling Township and some moved to the Township for the services. In addition, there is duplication with some agencies services and some collaboration between these agencies. Perhaps reducing funding of these agencies with similar services would force them into more collaboration and less duplication. The Township should consider eliminating nominal funding for agencies with large State and Federal grants because Township awards make no impact. Another possible cost savings is reducing funds to agencies with high salaries for executives and limiting funding to similar amounts awarded by other Townships. By spending efficiently the Township can still have greater impact.

2019-20 BUDGET DISCUSSIONS:

One pressing issue is getting bus drivers. Currently, the transit drivers' wages are \$14.00 per hour to \$16 per hour. The local school districts pay bus drivers \$18 per hour. The Township drivers have great responsibility to drive seniors and their pay should reflect that responsibility. The Township is short three drivers and had to limit

dial a ride. To meet the expected wages to keep and hire drivers, some agency funding may need to be reduced. The trustees can meet one on one or with Regina before the next meeting to discuss these issues. The final budget needs to be approved in May. Administrator Stapleton is meeting with staff to determine budgets and a 5 year plan. For example, determining what road management anticipates it will need to do over the next five years.
