CITIZENS TO BE HEARD

Mr. Gary Neuhardt and other citizens expressed concern about a residence in the unincorporated area, located at 3216 Salk Rd., Arlington Heights. The house and its surroundings is a huge mess with tall weeds and grass. Trees are about to fall, wild animals have access to the house, there is an odor coming out of the area, numerous broken cars are parked on the land, and the property has twenty three sheds. There is garbage piled on the property creating a bad odor. ComEd and the gas company have removed the lines to the house and do not provide service. The Cook County Sheriff has asked the neighbors to call if they see the owner. Administrator Stellato stated that the police have served the owner. A resident stated that the owner is a wanted felon. Supervisor Penner explained to the residents present, that the Wheeling Township does not own this property, and she and Trustee O'Connell will contact Gregg Goslin at Cook County to address the issue.

<u>ADMINISTRATIVE REPORT:</u> Administrator Stellato presented the board with her written report.

NEW BUSINESS

Melanie Santostefano from Vicarious Production, Inc., provides to townships and organizations social media, public information and public relations services. They are interested in creating Wheeling Township Facebook, Twitter, and LinkedIn pages, to share current Wheeling Township information with the public. Vicarious Productions would help submit monthly articles to news media for publication and Vicarious Productions would also include monthly management of a social media page such as Facebook, Twitter, and LinkedIn. Vicarious has various townships as clients, including Palatine Township, and understands township functions.

Judy Walther, 2016-17 Audit Discussion-

Judy Walter has done 2017 independent audit. The opinion is unmodified meaning everything is in accordance with generally accepted accounting principles. The Township's fund balance decreased about \$172,000 from the prior year bringing Township as of February 28, 2017 to about \$9,061,000 in fund balances. The last three years the fund balances have been reduced as the township planned. The 2016 property tax levy is down 13%. Total expenses are down 9% from the prior year. The Road District was abolished and the road fund is now entitled Road Management fund. General fund can cover 20 months of expenditures. General Assistance fund can cover 17 months of expenses compared to 20 months in the prior year. The Road Management Fund went from 15 to 12 months in the last year. All \$6 million in the bank is insured or covered by third parties. Auditor noted no internal control weaknesses and no material weaknesses. The auditor also stated that Township has one of the hardest working staffs. Finally, tax returns are almost done. Administrator Stellato noted the township does not file taxes, but has two non-for profits that must be filed.
