**ASSESSOR:** Assessor Sadler reported:

- BOARD OF REVIEW APPEALS
- Cook County Board of Review has opened a few townships for appeals; Wheeling Township may open in early October. We encourage taxpayers to email the Assessor's office with information and we can provide them comparables and instructions for filing an online appeal. Forms, including appeal forms, are available in the front entrance of the Township building and in the rear of the building in the information boxes. Constituents can leave the appeal forms in the drop box and we will deliver the appeals to the Board of Review.
- The Cook County Board of Review continues to work from home. They will hold telephone hearings rather than in person hearings for appellants who request a hearing for their appeal.
- 2019 TAX BILLS
- Property tax bills are due October 1<sup>st</sup>. After that, penalties are incurred.
- MAP PAGES
- 2019 map pages have been delivered. We are in the process of reviewing, making changes and replacing old pages.
- COOK COUNTY ASSESSOR APPEALS
- 2019 Decision letter results are expected to be mailed to Homeowners in the
  next few weeks. The Cook County Assessor has re-opened and will meet with a
  taxpayers by appointment only. The Cook County Assessor is operating with a
  staggered crew, so that not all employees are in the office every week.
