## SENIOR SCENE PROGRAMS



During the spring and summer of 1864 Grant's Army of the Potomac



**Cholesterol Screening:**

9:00 a.m. – 11:30 a.m. (Available to residents 18 years & older)

Eight hour fasting (water only) lipid profile including total cholesterol, HDL, LDL, triglycerides and blood sugar (\$15.00 charge) Cholesterol screenings require drawing of a blood sample from the fingertip.

## ALZHEIMER'S CAREGIVER SUPPORT GROUP

It is estimated that as many as 5.1 million Americans may have Alzheimer's disease. The incidence of the disease is rising with the aging of America. Providing care for someone with memory loss can be a labor of love, but it can also be exhausting and stressful.



Wheeling Township has partnered with the Alzheimer's Association-Greater Illinois Chapter to offer a monthly support group for caregivers of individuals with Alzheimer's disease. The support group is designed to provide emotional, educational and social support for caregivers through monthly scheduled meetings.

Karen McNeir, R.N., B.S.N. and Kris Freeman, M.A. will be Co-Facilitators of this group, offering help to participants in developing coping methods and encouraging caregivers to maintain their personal, physical and emotional health, as well as providing optimal care for the person with dementia.


### AARP – SMART DRIVER COURSE

In cooperation with AARP, Wheeling Township offers the AARP Smart Driver Course, designed to help you: **tune up** your driving skills, **learn** about normal age-related physical changes and how to adjust your driving to compensate and **reduce** your chances of receiving a traffic violation or getting into an accident. Call our office to register for one of the following two day sessions. A \$15.00 charge for AARP members and \$20.00 for non-members applies for the two session class. Checks should be made payable to AARP and mailed or dropped off at the Township Office prior to your first class. **Class time is 5:30 p.m. - 9:30 p.m. on the following dates:**

## TRANSPORTATION SERVICES

### More Than Just a Ride!

*Unable to drive? Looking for safe and affordable transportation?*

If you are age 60 and over or age 18 and over with a permanent disability, the Wheeling Township Transportation services may be an answer for your transportation needs. Our service hours are 9:00 a.m. to 3:30 p.m. Monday through Friday within the Wheeling Township boundaries, with some exceptions for medical services. If you are in need of our transportation services, please call the Wheeling Township Transportation Department at (847) 259-7743 for program services and eligibility.



## MOBILE DENTAL CLINIC



The Mobile Dental Clinic is a partnership with Northwest Community Hospital and Elk Grove, Palatine, Schaumburg and Wheeling Townships. It provides necessary dental care to residents who do not have resources to go to a general dentist. Residents must meet financial guidelines and there is a cost of \$30 per visit.

Services are by appointment only. Call us to see if you qualify.


Emergency Assistance is a one time financial grant open to any resident facing a life-threatening circumstance, such as eviction or utility disconnection. Residents must complete an application, provide verifications and qualify based on financial and non-financial factors.

## FROM THE GIVING GARDEN...



**Friendly Visitor Program** - Duties vary according to the senior or disabled individuals needs and the volunteers time constraints. The volunteer may open mail and read to a visually impaired person, pick up groceries or medication for a homebound individual, or take an individual to lunch or to the grocery store. The volunteer and client are screened and matched by staff.



**Food Pantry Assistant** - We are in need of assistants who can commit to on-going weekly or bi-monthly help. Spend time accepting and inspecting donations, stocking shelves and bagging food in the Wheeling Township's food pantry.

**Seasonal Giving Program Assistant** - Help Wheeling Township staff coordinate the needy student school supplies/backpack programs, as well as the holiday food and gift distribution programs through the Wheeling Township Community Center.



## From the Assessor – Jerry Sadler

### 2013 2ND INSTALLMENT PROPERTY TAX BILLS

The 2013 2nd Installment property tax bills are scheduled to be mailed on July 1, 2014, with a due date the first part of August 1, 2014. We recommend that you check the entire bill carefully and note bill has a brief summary of the tax bill calculation and any relevant exemptions. If an exemption is missing from the bill, you will need to complete a Certificate of Error form and submit it along with a copy of the current property tax bill and a copy of a valid driver's license or Illinois ID card with the address of the subject property to the Cook County Assessor's office. The Certificate of Error forms are available on line at [www.cookcountyassessor.com](http://www.cookcountyassessor.com) or at our office (847-259-1515), and all Cook County Assessor's offices. We can assist you with this process, but in order to serve you most efficiently please have a **recent property tax bill with your property index number (PIN) available**. The PIN is found at the top of the property tax bill. Although we can assist you with this process, only the Cook County Assessor can issue a corrected bill.

Property tax bills can be paid by mail, online or in person at any Chase Bank location or at the Cook County Treasurer's office in Chicago at the County Building at 118 N. Clark Street. If you need a duplicate bill, you will have to contact the Cook County Treasurer either online at [www.cookcountytreasurer.com](http://www.cookcountytreasurer.com) or by calling 312-443-5100. Check the back of the property tax bill for more details.

#### **"If my property value has decreased, why is my property tax increasing?"**

Property tax bills can increase even though market values and corresponding assessments are decreasing. This is because property tax is not solely dependent upon property values.

- The Illinois Department of Revenue sets the multiplier or equalizer annually, which is intended to ensure all properties are assessed at the same level of market value.
- The Cook County Clerk calculates the tax rates based on the total equalized assessed value (EAV) for all property in any given tax code area and the amount of money requested (levy) by each taxing body listed on the bill.
- The Cook County Treasurer then determines the individual bills and mails them.

This information is available on your 2nd installment tax bill.

### 2014 ASSESSMENT APPEALS

The Cook County Assessor has set 2014 assessment appeal dates for July 2014. Please note that as property taxes in Cook County are paid one year in arrears, these assessment appeals, if successful, affect 2014 second installment property tax bills paid in July 2015. Wheeling Township's opening filing date is tentatively scheduled for July 11, 2014. During the 30-day window established by the Cook County Assessor, you can submit an appeal online at [www.cookcountyassessor.com](http://www.cookcountyassessor.com) or with an appeal form available at that same site or from our office or any Cook County Assessor's office. Appeals are reviewed and decisions made by the Cook County Assessor's office. We are available to assist you by providing information and direction on filing your appeal. Again, you will need the permanent index number (PIN) when you visit or call our office. **Our phone number is 847-259-1515.**

The Cook County Assessor still maintains a branch office at both the Rolling Meadows and Skokie Circuit Courthouse buildings with staff to assist you as well.

### ANNUAL MEETING:

Wheeling Township's annual Town Meeting was held on April 8, 2014. **St. James Boy Scout Troop 166** did an outstanding job starting the meeting by presenting the colors. This is not a regular board meeting; it is the one meeting that the Town Clerk conducts. The Clerk reads the financial statements, until a moderator is elected by the registered voters (electors) attending the meeting.



Arlington Heights resident, and former Township Collector, Ken Jochum was elected moderator. Resolutions to authorize the Board to purchase loss and liability insurance, fund social service agencies, and set the date and time of the next meeting were voted upon and passed by the majority of the electors present. Mr. Jochum introduced the elected officials and those presenting reports. Supervisor Schroeder presented awards to volunteers and donors and made a formal dedication of the meeting room to Paula Ulreich, former Clerk.

### VEHICLE STICKERS:

For those living in unincorporated Wheeling Township – don't get a ticket, buy a vehicle sticker. They are available for purchase at Wheeling Township and will be valid until June 30, 2015. The cost for stickers varies, but generally an automobile is \$80, a small truck is \$100 and senior citizens (65 years and older) can receive up to two stickers free of charge. If you have purchased a vehicle within the last 30 days and you live in unincorporated Cook County, - you will not be charged a late fee. Please be aware that the Cook County Sheriff's Police will ticket vehicles registered in unincorporated Cook County that do not display a current sticker.

## From Highway Commissioner – Scott Saewart

### SPRING RAINS AND YOUR FLOOD DISASTER PLAN...

Although living near the Des Plaines River may provide beautiful scenery and ample wildlife, it also brings high humidity, pesky insects, unpredictable weather patterns and the ever-present fear of flooding. While not much can be done to keep Mother Nature at bay, we can take a few precautions to help protect our families and property from rising waters.

In the event flood waters do reach your home and property, it is wise to have a few items on hand to help minimize the damage and help you clean up after the flooding recedes.

#### **The following is a list of items and suggestions to consider for emergency preparedness:**

- Keep a good selection of hand tools accessible: shovel, rake, axe, hammer and nails, pry bar, sledge hammer, basic electrical tools, wrenches, screwdriver, staple gun, and staples.
- A stash of construction materials so you can temporarily repair damage to your home and keep it habitable: 2x4s, plywood, tarps, rolled plastic, and duct tape.
- A chain saw for clearing debris, generator and fuel as an alternate power supply, and sand bags to help divert the flow of water.
- A source of clean drinking water available, a minimum of 3 gallons per person per day for cooking and sanitation needs.
- Stock your pantry with a variety of easy-to-prepare nutritious foods: canned, dried, and dehydrated foodstuffs.
- Alternate lighting sources, such as lanterns, candles, and flashlights. Be sure to include a supply of fuel and extra batteries for each device.
- If your local sanitary systems is compromised, an improvised toilet can be made using a five gallon bucket, plastic garbage bag, and a spare toilet seat. After each use, pour a little chlorine bleach in the bag and dispose by either burning or bury deeply away from the home and drinking water sources.

At some point, you may have to evacuate you home. That decision should be made well before there is any real life threatening danger. Always have at least two ways to access and exit your property to ensure you can get out. The largest vehicle you own should be used for the evacuation because you may be living out of it for awhile. Get in the habit of always maintaining a minimum of a half tank of fuel in that vehicle. When leaving, bring along 10 gallons of water, additional food, medical kit, hygiene kit, \$1,000 cash in mixed bills, and copies of any important documentation such as insurance policies, property deeds, birth certificates, social security cards, passports, and bank account information.

Prior to leaving the home, close the valves on all gas supply lines and flip the main circuit breaker in your electrical panel to reduce the risk of fire. Close all exterior windows and doors, but leave them unlocked to allow access by emergency personnel. Place a note with your contact information on the front door and kitchen counter. Head for safety at a relative's home or hotel not affected by the flood. Monitor radio and television reports for updates on the flood levels and the all clear from emergency services.

We certainly do not want a repeat of last year's record flood, but since we have no control over these occurrences, it is important that each homeowner that may be affected have a flood disaster plan and kit to prepare for such an event.
