WE ARE GRATEFUL...

On behalf of the Wheeling Township elected officials and staff, we extend our sincerest gratitude to everyone that made the 2017 holiday programs a success.

Wheeling Township has no debt, one of the lowest tax rates, balanced budgets, and provides full transparency. Most of our operating revenues are derived from property taxes. We care for the community with a plethora of social services, while keeping the cost to taxpayers at a minimum. Many of our programs function with little or no cost to taxpayers because of our generous donors and a host of dedicated volunteers.



We thank each and every private donor, as well as business, church and community organization (*listed on page 5 and below*) for sharing the spirit of the season with those in need. At Thanksgiving we distributed 246 baskets filled with turkeys and staples that fed 922 people. The Christmas Adopt-A-Family program provided toys and clothing to 238 families, which included 622 children and 416 adults.

FROM THE ASSESSOR'S OFFICE

SENIOR RENEWAL APPLICATIONS WERE MAILED:

Senior Exemptions must be renewed every year. The Cook County Assessor's Office mailed renewal applications for property tax exemptions in January to seniors who applied for the senior exemption last year. You would only have received a renewal form if you applied last year and are living at the same residence. It is not too late to return the form if you have not yet done so. The renewal form that was mailed is a two-part application. **The front side of the renewal application must be completed by ALL seniors – EVEN IF YOU DO NOT QUALIFY FOR THE SENIOR FREEZE. You only need to complete the back side if your total gross household income is under \$65,000 for the 2016 income tax year.** This income limit has increased since last year. In order to qualify for the freeze, you must also have resided in your home as a principal residence as of January 1, 2016. The savings from the exemptions will appear on the second installment tax bills scheduled to be mailed in July of 2018. The first installment property tax bills are estimated bills (55% of the previous year's total). No exemptions are deducted from the first installment. **First installment bills are mailed in February and are due the 1st of March.**

ELIGIBILITY FOR SENIOR CITIZENS EXEMPTIONS (Born in 1952 or Earlier)

There are two senior citizen property tax exemptions:

- 1) The **Senior Exemption** is available to all seniors regardless of income. It reduces the Equalized Assessed Value on your 2nd Installment bill by 8,000. The 8,000 is multiplied by the current tax rate and deducted from the second installment property tax bill. This amount has increased from last year.
- 2) The **Senior Freeze** will provide seniors with additional savings if the combined **gross** income of **all** occupants in a senior's household is less than \$65,000 (for the income tax year 2016), and if the senior has been an owner-occupant of the house since January 1, 2016.

Exemptions can only be taken on one property, and that must be the owner's principal residence. If you have questions, need a form, or help in completing the form, please contact us at: 847-259-1515 - or visit the Wheeling Township Assessor's office. We ask that you **have the 14-digit property index number (PIN) available** when you call or visit with any property tax questions. The PIN can be found at the top of your property tax bill. If you need assistance filing for the Senior Freeze, we need to see your **2016** Federal income tax (1040) and a tax bill along with an I.D at the property address. Homeowners who were born in 1952 - and turned 65 in 2017, would not have received senior application forms when the senior renewal forms were mailed. A first-time applicant must complete the

2017 Senior Exemption application, or the 2017 Senior Freeze application and attach a copy of the most recent property tax bill and a current driver's license, or a valid Illinois State I.D with the address of the subject property. The forms are available at our office, or at www.cookcountyassessor.com. The application can be dropped at our office for forwarding to the Cook County Assessor's office, or mailed directly to the address on the form.

Homeowners born in 1953 and turn 65 in 2018 will be eligible for the senior exemptions in 2019 when Cook County property owners pay property taxes for 2018.

DISABLED PERSONS and DISABLED VETERANS RENEWAL FORMS

Disabled Persons or Disabled Veterans renewal exemption applications are mailed after the senior renewal exemption applications are mailed. Disabled Veterans must provide a current letter each year from the VA.

2017 ASSESSMENT APPEALS

If you appealed your 2017 assessed value with either the Cook County Assessor or the Cook County Board of Review and received a reduction, it will be reflected on the second installment tax bill.

2018 PRIMARY ELECTIONS and VOTER REGISTRATION:

On March 20, 2018 the Primary Election will be held for Governor, Statewide Offices, State Senator, State Representative, and U.S. Congressional Representative. These elections will select Party nominees for the respective offices. If you want to vote in these elections, now is time to make sure you are registered. If you are not registered, have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in these and future elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by the November 6, 2018 General Election, and live in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization. If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website elections.il.gov. If you don't have a driver's license or state ID, go to cookcountyclerk.com and complete the form online, print, sign and mail it to the address on the application. If you register by mail, you must bring a valid state issued picture identification when you vote for the first time.

ADDITIONAL INFORMATION ABOUT ELECTIONS & EARLY VOTING

Additional information can be found at <http://www.cookcountyclerk.com/elections/earlyvoting/Pages/EarlyVotingLocations.aspx>. Voters do not need to provide an excuse or reason why they cannot vote on Election Day. Government-issued photo ID is not required, but is helpful if there is a question about the voter's registration, address or signature. Providing an ID can also speed up the process because there are ID card readers at every polling place check-in station.

MAIL BALLOTS

Any registered suburban Cook County voter may request a mail ballot using this online application at <https://mailvoting.cookcountyclerk.com>. Once Cook County verifies your registration and processes your application, Cook County will send a paper ballot to the mailing address you designate on your application. The deadline to apply is five days before an election. If you do not have one of the online application requirements, or if you prefer to apply on paper, you may download, print and sign a mail ballot application and send it to the Cook County Clerk's office. You can also get a mail ballot application at our Clerk's office.

ELECTION JUDGES NEEDED

Those interested in earning some money while serving on Election Day can serve as election judges. Earn \$190 as an Election Judge or \$340 as an Equipment Judge. You must be a U.S. citizen registered to vote in Cook County or a High School student with at least a 3.0 GPA. The duties include completing online and hands-on training classes, helping set up the polling place with your fellow judges, and working Election Day from 5 a.m. until the results are transmitted and the equipment has been packed up at the end of the night. SNOW AND ICE CONTROL CONTRACT FOR WHEELING TOWNSHIP UNINCORPORATED ROADS:

One of the many services provided by Wheeling Township is snow and ice control for our unincorporated roads. In the past, we have contracted these services on an annual basis. This year, we put out a bid for providing a three year snow and ice control contract. This will give us continuity for these services and help budget the annual cost.

We are pleased to announce that Northfield Township was selected as the lowest qualified bidder for this three year contract. They have provided excellent service in the past and we are confident that

they will continue to provide that service for this and the next two winter seasons.

Although we have experienced a thaw period, please remember that the ground is frozen below the surface. This condition may cause temporary surface water ponding and frozen driveway culverts till spring arrives.



WELLNESS HOUSE HELPS CANCER PATIENTS WITH MINDFUL YOGA

WELLNESS HOUSE, a non-profit organization whose mission is to let you live your life with cancer and beyond, offers **MINDFUL YOGA** at the Wheeling Township Community Center every Monday morning from 10:00AM – 11:00AM. MOBILE DENTAL CLINIC

The Mobile Dental Clinic, established in 2003, is a partnership with Northwest Community Hospital and Elk Grove, Palatine, Schaumburg and Wheeling Townships. Many



residents struggle to pay rent and put food on the table for their families. The clinic provides necessary dental care to residents who do not have the resources to go to a dentist. Residents must meet financial guidelines and there is a cost of \$30 per visit. Services are by appointment only so call us to see if you qualify.

FUNDING FOR THESE AGENCIES PROVIDED BY WHEELING TOWNSHIP
