A referendum to abolish the Wheeling Township Road District passed by a substantial majority vote in the November 2016 General Election. As a result, starting January 1, 2017, the maintenance of the 5 miles of unincorporated roads within Wheeling Township is now the responsibility of the Township Board of Trustees. The need to elect a Highway Commissioner has been eliminated but staff, under the direction of the Board, will contract for all needed services. We are presently in transition mode but we expect no reduction in services to the unincorporated areas. Tom Neitzke, long time Deputy Highway Commissioner, now Highway Manager, will work with Township Administrator Jo Stellato to outsource services to ensure maintenance is done without interruption, in a timely manner, and within budget. The first order of business was to award a bid for snow and ice control for the winter months.

SENIOR RENEWAL APPLICATIONS WERE MAILED

Senior Exemptions must be renewed every year. Anyone who received a senior exemption on their property in the past and is still living in the same home, must submit a renewal form each year. The Cook County Assessor's Office mailed senior citizen renewal applications for senior citizen property tax exemptions in January. It is not too late to return the form if you have not yet done so.

The renewal form that was mailed is a two-part application. The front page of the renewal application must be completed by ALL seniors even if you do not qualify for the senior freeze. You only need to complete the back side if your total gross household income is under \$55,000 for the 2015 income tax year. The savings from the exemptions will appear on the second installment tax bills scheduled to be mailed in July of 2017. The first installment property tax bills are estimated bills (55% of the previous years total). No exemptions are deducted from the first installment. First installment bills are mailed in February and are due the 1st of March.

Eligibility for Senior Citizen Exemptions (Born in 1951 or Earlier)

There are two senior citizen property tax exemptions:

1) **The Senior Exemption**, available to all seniors regardless of income, reduces the Equalized Assessed Value on your 2nd Installment bill by 5,000. The 5,000 is multiplied by the current tax rate and deducted from the second installment property tax bill.

2) **The Senior Freeze** may provide some seniors with additional savings if the combined gross income of **all** occupants in a senior's household is less than \$55,000 (for income tax year 2015), and if the senior has been an owner-occupant of the house since January 1, 2015.

Exemptions can only be taken on one property, and that must be the **owner's principal residence**. If you have questions, need a form or need help in completing the form, please contact us at: 847-259-1515 or visit the Wheeling Township Assessor's office. We ask that you **have the 14-digit property index number (PIN) available** when you call or visit with any property tax questions. The PIN can be found at the top of your property tax bill. If you need assistance filing for the Senior Freeze, we need your **2015** Federal income tax (1040), and a tax bill.

Homeowners who were born in 1951 and turned sixty-five in 2016 will not receive senior application forms when the senior renewal forms are mailed. A first-time applicant must complete the 2016 Senior Exemption application or the 2016 Senior Freeze application and attach a copy of the most recent property tax bill and a current driver's license, or a valid Illinois State I.D at the address of the subject property. The forms are available at our office, or at **www.cookcountyassessor.com**. They can be dropped at our office for forwarding to the Cook County Assessor's office, or mailed directly to the address on the form.

Homeowners born in 1952 and turn 65 in 2017 will be eligible for the senior exemptions in 2018 when Cook County property owners pay property taxes for 2017.

2016 Assessment Appeals

If you appealed your 2016 assessed value with either the Cook County Assessor or the Cook County Board of Review and received a reduction, it will be reflected on the second installment tax bill. If you are a senior and are aligible for the senior frage, there is no need for you to file an appeal

2017 ELECTIONS & VOTER REGISTRATION

Although we just completed the General Election this past November, our local Township and Municipal elections will be held shortly. The Consolidated Primary Election will be held on February 28, 2017, and the Consolidated General Election on April 4, 2017. These elections will select your Wheeling Township Officials, local Mayors and Legislative Officials, including school

boards that directly affect our lives. If you want to vote in these elections, now is time to make sure you are registered. If you are not registered, have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in these elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), to be a citizen of the United States, 18 years of age or older by the April 4, 2017 Consolidated General Election, and to have lived in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization. If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website **elections.il.gov.** If you don't have a driver's license or state ID, go to **cookcountyclerk.com** and complete the form online, print, sign and mail it to the address on the application. If you register by mail, you must bring a valid state issued picture identification when you vote for the first time.

Providing a Government-issued photo ID is helpful if there is a question about the voter's registration, address or signature, and can also speed up the process.

Mail Ballots: Any registered suburban Cook County voter may request a mail ballot using the online application at https://mailvoting.cookcountyclerk. com. Once your registration is verified, the county will send a paper ballot to the mailing address on your application. The deadline to apply is five days before an election. Applications are also available at our Clerk's office.

Election Judges: Interested in earning some money while serving on election day? You can earn \$180 as an Election Judge or \$340 as an Equipment Judge. To qualify, you must be registered voter and live in Cook County. The duties include completing online and hands-on training classes, helping set up the polling place with your fellow judges, and working the entire Election Day.
