## CITIZENS TO BE HEARD:

Arlen Gould: wants the board to wait until fall to place the mental health referendum on the ballot.

Lorri Grainawi: doesn't want the mental health referendum to be placed in the primary election.

Rosemary Walter: thanked the Township board for its appointments to the Mental Health Board. Mentioned that the community is confused about a new mental health tax levy referendum,

Attorney Florey: previously met with Arlen Gould and Lorri Grainawi explaining the court case regarding the mental health referendum. Both Arlen and Lorri wanted the referendum to be placed on the ballot as soon as possible. If the board voted to place the tax levy referendum on the ballot, some could see that as the board supporting the levy increase, but that is not what it means. By placing the levy referendum on the ballot, the board was letting the voters choose with all the transparency required by law. Without full transparency, a legal challenge could undo years of levies and create millions of dollars in liability. The first opportunity to have the referendum placed on the ballot is in the primary elections. Putting the referendum on the ballot would be consistent with the community desire. The sooner we place the tax levy referendum on the ballot, the less confusion we will have going forward. The tax levies if approved, can also go into effect sooner than later. The suggestion of passing a law to retroactively fix a law is generally not allowed by the courts when the fix is substantive. A taxpayer could argue that the referendum to raise taxes was not transparent. This would be a big risk for the Township and would advise against it. Almost every attorney that I have spoken with agrees with the analysis.

Trustee Hamilton: asked if the tax levy doesn't pass in the referendum, do we still have the Mental Health Board. The answer is yes. In fact, the tax levy could be proposed again in a future election if it loses in the spring.

Supervisor Penner: We have an obligation to be transparent. We are just adding transparency to the language of the Mental Health tax levy. We want everyone that votes on the tax levy referendum to see the change and the amount of the tax increase. We need to do this to protect against future legal challenges to any levy. Relying on a legislative fix as explained does not remove the risk of a legal challenge. Therefore, we recommend placing the tax levy referendum in the primary elections which will be held in spring.

Daryl Talken: If the tax levy fails in spring, the Mental Health Board still can recommend how to allocate funds to mental health agencies.


# OFFICIALS' REPORT

### ASSESSOR'S REPORT:

- TAX YEAR 2022
- The Board of Review concluded the appeal session for Wheeling Township and the County.
- Wheeling Township had 12,646 residential appeals; 5,924 appeals were not changed 47%. 6,722 appeals were reduced 53%
- The Illinois Department of Revenue released the multiplier which will be reflected on the second installment tax bills. The new multiplier is 2.9237, down slightly from the previous year.
