CITIZENS TO BE HEARD

Hugh Brady-708 referendum passed. He argued for Wheeling Township to fund the 708 board and that there was no plan to raise \$8 million. Urged funding of \$1.5 million.

Lorri Grainawi- Elk Grove Township has about the same budget as Wheeling Township. They spend for social services about a million dollars.

Mike Domrzalski- When the referendum was proposed, the flyers said \$1.5 million on the low end and \$10 million on the high end. He suspects the levy will go to the high end and will be four-times what the township levy is to run the township. Questions to consider is the township government the best to deliver Mental Health Services? What will be the consequences? Extra staff? We will have to carry insurance?

John Saleta- Commends the Township Board for the courage to follow the law. The legal opinion shows the referendum was not legally done.

Amy Somary- Encourages to live stream the meetings. Appreciates that more information is on the township website. Wants to have more board packets to show as she knows that the board has been good with our money. Not asking the township to provide the 708 services but to tax and collect money and distribute to agencies.

Steve Polit- Only some 6.7% of the some 1,400 Townships have done 708 boards. Let's not jump in with large amounts, but see what others have done with 708.

Dan Patlak- The needs assessment is so expansive even if we doubled the budget, the costs would not be covered. He asked property tax increase proponents why they do not

ask the State to increase funding rather than create a new bureaucracy. Respects the vote if it was fair, transparent and legal, but the referendum was none of those things.

- TAX YEAR 2024
- The Cook County Assessor is open for appeals from Wheeling Township until October 7, 2024. Thus far we have handled over 750 appeals and anticipate hitting 800 by the ending of the filing period.

- Both the Assessor and the Board are on track to provide timely tax bills for 2024.
- As a reminder tax year 2025 will be a reassessment year.

ook County Board of Review Commissioner George Cardenas Urges Passage of a Property Tax Relief Fund (Chicago, IL) – Cook County Board of Review Commissioner George Cardenas (BOR-1) is calling for passage of a Property Tax Relief Fund and congratulates Commissioner Bridget Gainer and the Cook County Committee on Workforce, Housing & Community Development for filing a proposed resolution calling to create the fund. According to the Cook County Treasurer's Office, not only have county property taxes increased for 30 consecutive years, the 19 highest tax rates in the county are located in Chicago's south suburbs, disproportionately affecting working-class and lower-income taxpayers.

"Enough is enough. With property taxes representing an ever-increasing share of taxpayers' budgets, our working-class and lower-income households need property tax relief," said Cardenas. "I applaud the County Workforce, Housing & Community Development Committee for stepping up and taking the issue of property tax fairness head on. We are at an 'all options on the table' moment and desperately need to provide property tax relief for our residents."


Cardenas outlined his vision for statewide property tax circuit breaker legislation to the Chicago City Council's Committee on Housing and Real Estate on Wednesday, September 11th. The proposal, referenced in The Daily Line and Chicago Sun-Times, is designed to alleviate property tax burdens on working-class and low-income households by tying the property tax liability to their ability to pay. The legislation, which builds on a previous circuit breaker program for senior Illinoisans, would ensure that property taxes do not exceed a manageable percentage of household income.

"This is about fairness. Property taxes are divorced from a person's ability to pay. While middle-class homeowners are spending up to 6% of their income on property taxes, the wealthiest residents are paying just 1%," said Cardenas. "This inequity is unsustainable. It's forcing families out of their homes and renters to bear higher costs. By providing relief, we're creating an environment where communities can thrive instead of facing the constant pressure of rising housing costs."

While the details are not finalized, the proposed legislation would apply to Illinoisans with annual income up to \$75,000, adjusted annually for inflation and a home with an assessed value not exceeding \$350,000. Homeowners who would benefit from the program would receive a credit or rebate for property taxes that exceed 5% of their annual income, with a maximum annual credit set at \$5,000. The program would also extend to renters, where a claimed credit would be based on an estimated 20% of their annual rent representing property tax.

I. Period of Coverage

This proposal shall provide for snow removal services for the period beginning November 15th, 2024 and ending March 31st, 2025.

II. General Conditions

A. Commencement

Snow removal operations shall begin upon an accumulation of one (1) inch.

B. Responsibilities

AB Sanchez, Inc. shall be responsible for plow operations on all specified private streets, driveway/parking areas, and all other designated common areas. The above areas will not be cleared if there are obstructions such as cars. These areas will be cleared after the first pass through the site. Previously blocked areas will be cleared if they are open.

C. Sidewalks

Sidewalks will be blown or hand shoveled upon an accumulation of one (1) inch. City sidewalks are included.

III. Salt/Sodium Chloride

- Salt applications to sidewalks and lots below 1 inch shall be made at our discretion and invoiced at \$185.00 per application unless checked off on page 4.

A. Roadways and Driveways

Blizzard conditions or where accumulation rates are more than ten (10) inches within a twenty-four (24) hour period shall be considered extreme. Any single snow event of ten (10) inches or more will be invoiced at rates shown on the attached fee schedule. AB Sanchez, Inc. will use any available equipment to safely complete snow removal operations, without prior consent from managing agent.

B. Snow Relocation On Site/Removal Off Site

Other call backs may be chargeable depending upon existing circumstances. Any callbacks received after twenty-four (24) hour period starting at the completion of snow operations will be charged according to the attached time and materials.

VI. Damage

A. Plowing

AB Sanchez, Inc. shall be responsible for damaged caused to site from snow removal efforts. Repairs and replacements will be made as soon as possible and reasonable. Claims for damages will not be accepted after April 30th. Displaced turf will be reinstalled when possible. A full assessment of turf damage will be conducted in spring with damages areas repaired with topsoil, seed and germination blanket where appropriate. Seeded areas will receive the initial watering after which time this becomes the owner's responsibility.

B. Salting
