#### Mission Statement

To ensure that services related to mental illness, developmental disabilities, and substance abuse are available and known to the residents of Wheeling Township.

In light of our mission statement, the recently completed assessment, and our ongoing commitment to maintain and improve the mental health of our community, focusing on those most in need: those with mental illness, intellectual and developmental disability and substance use disorder, we submit this 1 and 3 year plan for the Wheeling Township Community Mental Health Board.

#### Year One

- 1. Hire a Mental Health Board Manager.
- Review contracting procedures with funded agencies to institute the use of Expenditure-Reimbursement Grants.
- 3. Maintain/increase funding specific to existing Funded Agencies and new applicants when appropriate.
- 4. Review Transportation service options to implement as appropriate.
- 5. Expand the information available on the 708 Board page of the Wheeling Township website.
- 6. Contract translation service in conjunction with the Township.
- 7. Site visit to evaluate and familiarize Board members with programs.
- 8. Mental Health Fair

- 1. Referral Program Management and software
- 2. Encourage staffing in the community.
- 3. Community outreach.
- 4. Evaluate the effectiveness of existing programs.
- 5. Establish a respite program for care givers
- 6. Re -evaluation of the Community
- 7. Apply for Grants
- 8. Create a 501c (3)

# WHEELING TOWNSHIP COMMUNITY MENTAL HEALTH BOARD ANNUAL REPORT

#### MARCH 1, 2024-FEBRUARY 28, 2025

The Wheeling Township Community Mental Health Board made significant progress in the year ending February 28, 2025. An early accomplishment in the year was approval of a Community Survey conducted in 2023. The survey was coordinated by the Township staff.

In May of 2024, the Community Mental Health Board approved a Policies Manual. This document addresses a number of organizational matters such as Meetings, Powers and Duties, Conflicts of Interest and the procedure for amending the Policies Manual.

Pursuant to State Law and the Policies Manual the Board elected officers for the 1-year period beginning July 1, 2024. Those elected were Susan Hayes-President, James Ruffatto-Vice President, and Bill Dixon-Secretary.

Efforts to better inform the public of Community Mental Health Board activities were enhanced by placing Meeting agenda and back-up materials on the Township website.

A major undertaking began with selection of Harper College Business Solutions to conduct a Needs Assessment. Funding for this activity was provided by the Wheeling Township Board.

The Needs Assessment was finalized and subsequently presented to the Community Mental Health Board in September of 2024 by Harper College Business Solutions. The Assessment provided valuable data and numerous recommendations. One of the noteworthy suggestions was a formula regarding allocation of funds to agencies. The report recommended that 50% of funding be devoted to Mental Health, 30% be allocated to Intellectual and Developmental Disabilities and 20% be allocated for Substance Use Disorder.

Drawing upon the Needs Assessment, the Board discussed the one and three year plans in January of 2025 and anticipates adopting them in March 2025. A copy of those plans is attached.

The Board learned of changes in State Law pertaining to Community Mental Health Boards. Some of the modifications dealt with Board vacancies, Reporting deadlines, Ballot language, and Property Tax Extension Law Limits.

Board Member JoAnne Schultz's term expired on February 28, 2025. Ms. Schultz chose not to seek reappointment. At the Meeting of January 8, 2025, the Community Mental Health Board thanked Ms. Schultz for her valuable service to Wheeling Township and the Community Mental Health Board over the years and wished her the best. Supervisor Penner will likely appoint someone to fill the vacancy in April.
