CALL TO ORDER

The Mental Health Board Meeting of Wheeling Township, for October 2, 2024 was held in the Paula Ulreich Meeting Room, in the Township of Wheeling, 1616 North Arlington Heights Road, Arlington Heights, Illinois. President Susan Hayes called the meeting to order at 7:00 p.m.

President Susan Hayes led those assembled in the Pledge of Allegiance.

APPROVAL OF MINUTES

MOTION #1: APPROVAL OF THE MINUTES OF THE WHEELING TOWNSHIP COMMUNITY MENTAL HEALTH BOARD MEETING ON SEPTEMBER 11, 2024.

Motion by Jim Ruffatto, seconded by JoAnne Schultz, to approve the September 11, 2024 Wheeling Township Community Mental Health Board Meeting minutes.

CITIZENS TO BE HEARD

Dan Patlak, a resident of Wheeling, opposed the tax increase to fund Mental Health not because he didn't think there was a need for it but because he believes tiny government like a Township should not take on the responsibility through an increased property tax. He asked the referendum organizers prior to placing it on the ballot if they had lobbied local, federal, state, or county representatives, they had not. He stated that property owners in Illinois have the second-highest taxes in the nation. He learned the language was illegal and the Township could not levy. The Board voted to put a correctly worded referendum back on the ballot so the voters could make a fully informed decision about paying more property taxes. He then stated that legislators passed a bill to fix the

language more or less giving the referendum organizers a pass. He also stated state legislators passed a law to remove tax caps on Mental Health Boards which could allow future boards to increase our taxes by 8.6 million and beyond as the value of property continues to increase. He hopes members of the Board and the public will take notice.

Bill Dixon asked attorney Ken Florey if the Wheeling Township Board was going to take an initiative to get the referendum on the ballot. Ken Florey stated it has not been decided yet.
